#### 1. INTRODUCTION

Ministry of Environment, Forest and Climate change, in its' gazette notification dated 7th December 2015, has amended the Environment (Protection) Rules, 1986, which inter alia, makes it binding to Thermal Power Plants to reduce Sulphur di oxide (SO2) emission below the prescribed limit, depending on Unit size and year of installation of Power Plants. For the purpose of capturing SO2from the flue gas before emission, Flue Gas Desulphurization (FGD) plants are required to be installed in the Flue gas path. In complying with the said gazette notification, UPRVUNL shall also install an FGD plant in its 2X500MW, ATP, Anpara Plant.
